4.2.3, 4.2.4	Renumbers section to new Section 5 and changes the term of office for the Secretary and Treasurer to a 2-year term instead of a 1-year term

4.2.5, 4.2.5.1, 4.2.5.2	Moved into new Section 5.2.6. Nominations; includes updated petition nomination information and responsibilities of the nominations and elections committee per Society recommendation
4.2.6	Renumbered to Section 5.2.7. Election of Officers and Directors; changes the election process from a ballot method to a slate method to match Society recommendation
4.3	Renumbered to 5.3. Added language for filling vacancies with unexpired term.
